MOTION TO ENFORCE PROTECTIVE ORDER

AMMON BUNDY, et al.,

The United States of America, by Billy J. Williams, United States Attorney for the District of Oregon, through Ethan D. Knight, Geoffrey A. Barrow, Craig J. Gabriel, and Pamala R. Holsinger, Assistant United States Attorneys, hereby moves this Court for an order enforcing the Protective Order (ECF No. 342) against a third party illegally in possession of protected sensitive discovery materials in this case.

The United States has developed information, detailed in the Affidavit of Special Agent Ronnie Walker, that an individual named Gary Hunt, operating a website known as "outpost-of-freedom.com" has received discovery subject to this Court's March 24, 2016, Protective Order. Third-party Gary Hunt is neither a defendant in this case, nor a person employed by an attorney of record to assist in the defense preparation of the case. Accordingly, Gary Hunt is not an individual authorized to receive or disseminate the discovery produced under this Court's Protective Order.

This Court has jurisdiction to enjoin a non-party from disseminating confidential documents produced in reliance upon and subject to this Court's Protective Order. *See Eli Lilly & Co. v. Gottstein*, 617 F.3d 186, 194-95 (2d Cir. 2010) (affirming district court injunction against non-party who aided and abetted party's violation of court's protective order).

Protective orders serve important functions and they cannot and should not be defeated either directly or indirectly by non-parties. *See, e.g., In re Special Proceedings*, 291 F. Supp. 2d 44, 50 (D.R.I. 2003) (holding protective order entered in criminal case was enforceable against a non-party post-trial). By letter dated January 4, 2017, third-party Gary Hunt received actual notice of this Court's Protective Order (see attached letter). Gary Hunt failed to respond within twenty-four hours as requested, which prompted the United States to seek relief from this Court. As explained in greater detail in Agent Walker's affidavit, public dissemination of the material produced under this Court's Protective Order could threaten ongoing investigations and the safety of government confidential human sources, informants or others.

Accordingly, the United States asks that this Court order relief similar to that directed in *Eli Lilly*: direct Gary Hunt to immediately remove all protected material from his website(s)

and enjoin Gary Hunt from further disseminating the documents subject to this Court's Protective Order.
